Any person whose name appears on an unauthorised sign or whose product or services are advertised on such sign, shall be deemed the owner of such sign and shall be liable for any default fees/charges, until the contrary is proved by that person.

Any person that is the owner of land or building on which any unauthorised sign was or is displayed, shall be deemed the owner of such sign and shall be liable for any default fees/charges, until the contrary is proved by that person.

A business operating permit is required by any owner of a sign or advertisement structure advertising the products, services, events etc of another person, except where the sign or advertisement structure is on the business premises or venue carrying on the business of the advertised products, services, events etc.

NOTE 1.

These permit fees are levied by the La Dade-Kotopon Municipal Assembly in accordance with the " Accra Metropolitan Assembly (Business Operating Fees) Bye-Laws (2016) " and have taken due consideration of the size and type (nature) of profession, business, occupation, trade etc. being carried out.

NOTE 2.

The charges stipulated in this item fall under two main classifications:

a) " Levies " which used to be charged by the Ministry of Energy and Mines based on the capacity of the filling or, service station and which the Ministry of Energy and Mines has now authorized the Assembly to collect and retain as revenue. These levies are what have been indicated in (a) under the item.

b) " Business Operating Permit Fees " which are charged annually by the Assembly to various filling and service stations in accordance with the Accra Metropolitan Assembly (Business Operating Permit) Bye-Law (2016). These Permit Fees are shown in (b) of the item. The above exposition presupposes that those businesses in (b) pay the levies in (a) as well depending on the capacity of the station.

c) "Any arrears outstanding after the due date for settlement shall attract a penalty of 30% of the amount owned.

NOTE 3.

Contractors under this item have been classified into four (4) categories using the pre-qualification criteria of the Ministries of Works and Housing and Roads and Transport. It shall be the duty of every person liable to pay an operating permit fee and/or any annual fees to settle the amount thereof at the offices of the La Dade-Kotopon Municipal Assembly on or before 31st March, 2016

NOTE 4

"The full cost of the above plates shall be determined based on current market, administrative and overhead costs" The surcharges for affixing of plates shall include cost of capital [interest] used in the provision of the plate(s).

NOTE 5

The minimum franchise fee to run a private car park (e.g. Makola Mall Underground Car Park std) is Five Thousand Three Hundred and Twenty Four Ghana Cedis (GH¢5,324.00) p.a. This excludes B.O.P. Fees.

NOTE 6

The Special Trade Permit Stickers and sellers ID Card will be required by any truck, vendor, company, seller that shall trade in the La Municipal Area. Stickers shall be issued one per truck per month and shall expire at the end of every month irrespective of the date that it was issued. Sellers ID Tag shall be issued one per person perquarterly and shall expire at the end of every quarter irrespective of the date that is was issued.

All Mineral and Filtered Drinking Water Producers, Alcoholic and Non Alcoholic Beverage Producers, Ice Cream Producers, Cocoa Drink, Bread, Plastic Shopping, Carry Bags, Plastic Rolls & Sheeting, Ice Water/Cocoa Drink/Ice Cream/Bread Sellers who shall do Business and or trade in the La Dade-Kotopon Municipal Area will be required to Register with the Project Secretariat, and apply for a APWMP Sticker Permit or Seller ID Tag. Before you are issued with a Permit, the company must provide the following:

1. Business Registration Certificate
2. Certificate to Commence Business
3. LaDMA Business Operating Permit
4. Ghana Standard Board or Food & Drugs Board Certificate
5. Full Business Address & Contact Details
